Section A: JOINTLY DEVELOPED

Wright Elementary will take the following actions to involve parents in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

This Policy will be revisited and appropriately revised in collaboration with parents during the Spring of the preceding school year at the Spring Title I Parental Input Meeting. This year the parent meeting was held on May 18, 2022.

Parents and families are invited to further review and improve engagement programs via the annual Winter Meeting, regular SAC meetings, and surveys at the school and District levels.

Section B: ANNUAL TITLE I MEETING

Wright Elementary will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' requirements, the school parent and family engagement policy, the schoolwide plan, and the school-parent compact.

The Title I Annual Parent meeting will be held during the Back to School event which will take place annually during the month of September. This will include a presentation by the principal or designee on the requirements of Title I part A, parent rights and responsibilities under the law, the state academic content standards and assessments (PSSAs), working with educators, monitoring student progress, and the school curriculum and academic supports that are available to students.

Topics covered during this evening meeting will be reviewed and discussed during a morning parent meeting to ensure that families have access to the information. In the event that schools return to increased in person participation. Virtual parent participation will remain as an option.

Wright Elementary will take the following actions to provide parents of participating children with (1) Timely information about the Title I programs, (2) Flexible number of meetings, such as meetings in the morning or evening, (3) transportation, child care or home visits, as such services relate to parent and family engagement and may use Title I funds and (4) Information related to the school and parent programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request and, to the extent practicable, in a language the parents can understand.

The Parent and Family Engagement Plan and School-Parent Compact will be available at parent meetings; on the website; and distributed electronically via student/family gmail account.

Meetings will be held at various times to increase parent ability to attend.

Communications between the school and families will be sent home in parent-friendly language. Translation services are available in multiple languages and interpreters are available upon request.

The school communicates regularly with parents/families via Class Dojo notices and messages; the Parent Portal; School Calendars; Report Card Conferences and Instagram.

Parents will conference on the child(ren)'s academic progress three times a year. We will work to coordinate conferences at different times of day in order to best accommodate the schedules of parents/families. These will be held as follows: November 21 – 23, 2022; February 1 – 3, 2023; March 29 – 31, 2023.

Interim reports will be shared as follows: October 12 – 14, 2022; December 21 – 22, 2022; February 27 – March 1, 2023; May 8 – 10, 2023.

Section D: SCHOOL-PARENT COMPACT

Wright Elementary will take the following actions to jointly develop with parents of participating children a school-parent compact that outlines how parents, the entire school staff, and students will share the responsibility for improved student academic achievement and the means by which the school and parents will build and develop a partnership to help children achieve the state's high standards.

Parents will be invited for revision in the Spring of each School year at the Spring Title I parent engagement meeting. This year, the parent input meeting was held on May 18, 2022.

The family involvement portion of the Title I budget is discussed at the beginning of the school year during the Title I meeting and revisited as necessary throughout the year. Input as to spending is solicited regularly, but particularly at the Annual Winter Parent Meeting during which the school plan and budget is reviewed, with particular emphasis on the 1% parent set aside. The last such meeting occurred on February 23, 2022.

Section F: COORDINATION OF SERVICES

Wright Elementary will, to the extent feasible and appropriate, coordinate and integrate parent and family engagement programs and activities with other Federal, State, and local programs, including public preschool programs, and conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children by:

Organizing workshops for parents around topics/ subjects that they request, or that teachers see will support more academically productive engagement.

Work with the district to organize and conduct transition meetings with the pre-Kindergarten program and the middle schools are students and families work with.

In the fall, the counselor supports parents with the middle school selection process via telephone calls. In addition, the counselor will complete the actual application online for struggling parents. Once the acceptance notices are posted, the counselor notifies parents and students of the deadlines to accept their final placement.

Communicate workshops and programs offered by our local CUA office.

Collaborate with the District's Office of Family and Community Engagement to provide parents and families with information and training to better support their child's academic success and social emotional well being.

Section G: BUILDING CAPACITY OF PARENTS

Wright Elementary will build the parents' capacity for strong parent and family engagement to ensure effective involvement of parents and to support a partnership among the school and the community to improve student academic achievement through the following:

- Providing parents with a description and explanation of the curriculum in use at the school, the forms of academic assessments used to measure student progress, and the achievement levels of the challenging State academic standards; and
- Materials and training to help parents to work with their child to improve their child's achievement, such as literacy training and using technology (including education about the harms of copyright piracy), as appropriate, to foster parent and family engagement
- Providing assistance to parents of participating children, as appropriate, in understanding topics such as the following:
 - The challenging State's academic standards
 - The State and local academic assessments including alternate assessments
 - The requirements of Title I, Part A
 - How to monitor their child's progress
 - How to work with educators to improve the achievement of their child

With the support of the FACE Office, Wright school will provide a minimum of two combined SAC/workshops on topics such as how to use the Parent Portal/progress monitoring, attendance, literacy and math. Stand alone Volunteer Orientation will be offered in September or October.

During Winter 22/23 Wright will host the Winter Meeting and a Move-Up to Middle School workshop. In Spring 2023 a Growth Mindset Workshop and a Parent Portal training will be offered.

Parents will be surveyed to solicit feedback about which workshop topics are most desired.

The Title I Annual Parent meeting will be held during the Back to School event which will take place annually during the month of September. This will include a presentation by the principal or designee on the requirements of Title I part A, parent rights and responsibilities under the law, the state academic content standards and assessments (PSSAs), working with educators, monitoring student progress, and the school curriculum and academic supports that are available to students.

Parents would like to return to in-person meetings if Covid restrictions permit.

Section H: BUILDING CAPACITY OF SCHOOL STAFF

Wright Elementary will provide training to educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school by:

Professional Development will be held at the opening of each school year and followed up on throughout the school year as the district schedule allows. During a district PD day in Fall/Winter 22-23, staff will be trained on effective parent engagement and communication by the Principal or their designee. This will include a review of the results of the school level parent survey and the State Parent Advisory Council skits.

Wright Elementary will provide other reasonable support for parent and family engagement activities under Section 1116 as parents may request by:
